Migrant: Someone who moves from one place to another in order to live in another country for more than a year.

There are a lot of reasons (better life expectations, economics, academic career, climate...etc.) to motive young people* for migration.

^{*:} According to UN report in 2016, 12% (28 million) of 232 million international migrants are young migrants between 15-24 years old.

Refugee: A person who has fled armed conflict who is recognised as needing of international protection because it is too dangerous for them to return home.



They are protected under international law by the 1951 refugee convention, which defines what a refugee* is and outlines the basic rights afforded to them.

*: The UN refugee agency (UNHCR) estimates that there are almost 60 million forcibly displaced people around the world, including those displaced within their own countries.

SEEKING ASYLUM IS A HUMAN RIGHT


An asylum-seeker is someone whose request for sanctuary has yet to be processed.


Every year, around one million people seek asylum*.


